Panayotis Tournikiotis was born in Athens, Greece, 1955, and he is now professor of Theory of Architecture and Dean at the School of Architecture, National Technical University of Athens.

Panayotis Tournikiotis is teaching **history and theory** of architecture at the School of Architecture, National Technical University of **Athens**. He first enrolled in 1991 as an Adjunct professor of theory of architecture. In 1995 he was appointed as assistant professor and in 2004 as associate professor. Since 2009 he is full **professor** of theory of architecture. He is now the director of the History and Theory of Architecture Laboratory.

During 2004-2005 he was named at the board of directors of the new department of Architecture, at the Technical University of Crete and was responsible for the teaching curriculum; he was also appointed there as associate professor of history and theory.

He has also participated in the scientific and/or organizing committees of many national and international conferences, architectural exhibitions and events.
